Subject: Presentation: Cooling Centers in the Coachella Valley

Recommendation: Information

Background: In anticipation of the summer weather, Riverside County Community Action Partnership (CAP) annually opens cooling centers that serve as drop-in sites for vulnerable individuals, homeless individuals, seniors, persons with disabilities, and others in need of temporary relief from extreme heat. These centers are typically located at libraries, senior centers, community centers, and other non-profit or faith-based organizations. When temperatures are expected to reach 100 degrees or higher, CAP and the Riverside University Health System of Public Health issue an official heat warning and activates all the cooling centers.

Cooling centers generally operate during the daytime hours. For the first time in several years, based on direction by the Cathedral City Council, the local options are expanded to include a cooling center at the Cathedral City Library. CVAG does not directly operate a cooling center, but has supported the program. This included securing grant funds in 2019 and then partnering with the County of Riverside and City of Palm Springs to temporarily extend a cooling center at Demuth Community Center into an overnight program.

CAP Division Manager Monica Santana will attend the June meeting to provide the Homelessness Committee additional details about the deployment of cooling centers this summer.

Fiscal Analysis: There is no cost to CVAG for this update.

Subject: Phased Opening of the Palm Springs Navigation Center

Recommendation: Information

Background: In March 2024, the first phase of the Palm Springs Navigation Center opened in the City of Palm Springs. CVAG’s Homelessness Committee received an update at its February meeting from Palm Springs Deputy City Manager Flinn Fagg. At the June meeting, the Committee will be provided an update on the operations to date as well as a tour of the construction site.

The campus was designed as a location where shelter, food and a full suite of support services can be co-located to expand the region’s network of services for homeless individuals and reduce secondary impacts that can negatively impact quality of life. The first phase is an early entry facility and the rest of the campus open in July 2024. The project was highlighted at the February 1 homelessness symposium that was hosted by Riverside County Supervisor V. Manuel Perez.

The navigation center is located on 3.64 acres along McCarthy Road in the City of Palm Springs. The site has three existing buildings totaling 46,760 square feet. The campus will consist of a shelter facility, 80 modular housing units and full wrap-around services that will include behavioral health care, workforce training, linkage to state and county services, and other resources to get unhoused individuals linked to permanent housing.

The center’s focus will be to provide services to help individuals transition into permanent housing. In the future, in addition to providing services directly to homeless individuals, the City and the County have identified the potential to provide services to housed residents such as childcare; assisting individuals with securing health, disability, social security, and other benefits; computer skills, access to internet, employment support and assessments; basic first aid; computer labs; and referrals to other resources. An appropriately sized facility and property could also provide an opportunity to co-locate other services, including the county’s mental and/or behavioral health programs, or to have an on-site medical clinic.

After an overview presentation, Palm Springs city officials will provide walking tours of the current facility and future buildings. This is an active construction site, so closed-toe shoes are required and safety vests will be available.

Fiscal Analysis: There is no cost to CVAG for this update.

City and county officials have noted that the project’s estimated costs have gone up as overall costs of construction have risen. More than \$40 million was secured for the creation and operation

of the campus. In August 2022, Riverside County and the City of Palm Springs announced they were receiving a \$19 million grant from the state's Homekey Program to build and operate the Palm Springs Navigation Center. Riverside County contributed \$18 million and the City of Palm Springs contributed \$8.16 million.

In addition to funding design, renovations and construction, the City and County has secured funding for operational dollars for Martha's Village & Kitchen, which has been selected by the city as the center's operator.
