Subject: Presentation: Preparing for the Big One in the Coachella Valley

Recommendation: Information

<u>Background</u>: Given the geographic proximity to the San Andreas fault line, earthquake preparedness is of upmost importance for the Coachella Valley. It also has been a longstanding topic of interest for CVAG's committees. In 2009, the CVAG Executive Committee approved CVAG's participation to colead the creation and implementation of the Coachella Valley Regional Earth Early Warning System (CREWS) with the Coachella Valley Emergency Managers Association (CVEMA). Now, the Coachella Valley CREWS system has stand-alone, non-networked earthquake warning systems and four dispatch centers.

In recent years, Public Safety Committee members have been provided with various updates on the Earthquake Warning California (EWC), which is the state's earthquake preparedness system. That included a 2020 presentation on the MyShake app, which is a component of the EWC system that serves as a useful tool to help families, businesses, and communities prepare for earthquakes to "Drop, Cover, and Hold on" in advance of an earthquake. In September 2021, in anticipation of International Shakeout Day, the Committee heard from the manager of the California Institute of Technology (Caltech) Seismological Laboratory's Office of Earthquake Programs.

Recent advancements such as the first-in-the-nation Earthquake Early Warning System have allowed Californians to be better prepared. This includes work by the Southern California Earthquake Center, which is headquartered at University of Southern California. With funding from the National Science Foundation and the U.S. Geological Survey, the center has transitioned to become the Statewide California Earthquake Center (SCEC). It is now leading research and collaboration opportunities that span across California and stretch to western Nevada to Baja California and Cape Mendocino.

Mark Benthien, SCEC's Director of Communication, Education and Outreach, will join the Public Safety Committee meeting by Zoom to discuss some key issues for the Coachella Valley and what resources SCEC has for local communities.

<u>Recommendation</u>: Following a presentation by the City of Blythe, authorize the Chair and/or Executive Director to advocate for a public hearing by the Governor's Office and/or the California Department of Corrections and Rehabilitation to address the planned closure of Chuckawalla Valley State Prison

<u>Background</u>: In February 2023, the CVAG Executive Committee supported the Public Safety Committee's Recommendation to direct the Executive Director to assist the City of Blythe in its request to reexamine and reconsider the closure of Chuckawalla Valley State Prison and, if that closure appears to move forward, to advocate for the repurposing of the facility and meaningful mitigation measures.

CVAG's vote came just months after the California Department of Corrections and Rehabilitation (CDCR) announced in December 2022 that it was starting the process to close Chuckawalla Valley State Prison in the City of Blythe, with an anticipated closure in March 2025. The decision coincides with a plan to end its lease at the California City Correctional Facility in Kern County.

Chuckawalla Valley State Prison, which opened in 1988, occupies about 125 acres and is adjacent to Ironwood State Prison. Chuckawalla was designed to house for 1,738 inmates but had 2,733 inmates as of 2019, which were the most recent statistics presented on the CDCR website. Chuckawalla includes four Level II Non-Designated Programming Facility Yards and one Level I Non-Designated Programming Facility Yard. The prison also maintains operation of a fire house, water treatment plant, waste water treatment plant, the vehicle maintenance garage, and a recycling and salvage program.

In announcing the prison closure (news release attached), state officials said the decision was part of the 2022-23 budget and that Chuckwalla was chosen after an analyzing "several factors including cost to operate, impact of closure on the surrounding communities and the workforce; housing needs for all populations; long-term investments in state-owned and operated correctional facilities; public safety and rehabilitation; and durability of the state's solution to prison overcrowding."

The CDCR statement also noted that "the Administration plans to work directly with community stakeholders in Riverside County to help support workers and foster a bottom-up economic resilience plan for the community impacted by the closure." Additionally, the state pledged to minimize the impact to staff and the communities, including identifying opportunities for employee transfers. Inmates will be rehoused at appropriate level prisons.

Representatives from the CDCR – including Prison Closure Manager Charles "Chuck" Callahan, External Affairs Deputy Chief David Maldonado and Deputy Director of EDD Workforce Javier Romero – attended the February meeting of CVAG's Public Safety Committee to provide an update of the plans. This gave the Public Safety Committee a chance to have questions answered prior to acting on a request from the City of Blythe to actively oppose the decision.

Blythe city officials have expressed strong concerns about the economic impacts that will result from the closure of Chuckawalla Valley State Prison, not just in terms of job loss but also on the positive impact the prison has in maintaining facilities for the city. There was an effort to convince the staff to keep Chuckawalla open, and instead phase out the California Rehabilitation Center in Norco, an older facility which, if closed, was expected to have less of an economic hit. Those efforts have proven unsuccessful and city officials have said that sections of Chuckawalla have started to close.

The Blythe City Council in January 2023 authorized contracts with both a lobbying firm and a public relations firm to address the planned closure. A "Save Chuck" campaign has gotten some attention. The County of Riverside also commissioned a resiliency study, led by Kosmont Companies, to look at the potential economic drivers for Blythe should the closure go through. The results were presented to the Blythe City Council in March 2025.

City officials have repeatedly expressed frustration that their voices are falling on deaf ears. In April 2024, CVAG staff attended the 66th Annual Community Outlook Conference, where the prison closure was discussed at length. City officials are now pressing for a public hearing or workshop in the community so that residents can voice their concerns directly to state officials.

Blythe Vice Mayor Johnny Rodriguez and Interim City Manager Mallory Crecelius will provide an update to the Public Safety Committee when it meets in May. Following the presentation, CVAG staff is recommending that CVAG broaden its current authorization and authorize that the Chair and/or Executive Director advocate for a public hearing, held in the City of Blythe, by either the Governor's Office and/or the California Department of Corrections and Rehabilitation to address the planned closure of Chuckawalla Valley State Prison.

<u>Fiscal Analysis</u>: There is no cost to CVAG for this update. Advocacy efforts related to Chuckawalla Valley State Prison are covered under the existing contract with Politico Group and staff time.

California Department of Corrections and Rehabilitation Announces the Planned Closure of Chuckawalla Valley State Prison

DECEMBER 6, 2022

State will support local community and workforce with an economic resiliency plan and workers will be offered transfers to nearby facilities

SACRAMENTO — As outlined in the 2022-23 budget with an eye toward fiscal responsibility, CDCR is moving forward with closing one prison and ceasing operation of another leased facility as a state prison, and will deactivate some facilities within six prisons.

CDCR and the Administration are working to minimize impact to staff and the communities. CDCR will work to limit the impact to employees affected by these closures and deactivations. This will include options to transfer both within and outside of impacted counties, and identification of employees for redirection to neighboring prisons where there are existing identified vacancies.

The California Department of Corrections and Rehabilitation (CDCR) will begin the process to close Chuckawalla Valley State Prison (CVSP) in Blythe, with an anticipated closure in March 2025. Similar to the recent announcement by the Administration

Additionally, the department will exit the \$32 million, annual lease with CoreCivic for California City Correctional Facility, terminating the contract in March 2024, effectively ending the use of that facility as a state prison.

The department is also planning the deactivation of certain facilities in six prisons, including: Folsom Women's Facility; Facility C in Pelican Bay State Prison; West Facility in California Men's Colony; Facility A in California Rehabilitation Center; Facility D in California Institution for Men; and Facility D in California Correctional Institution. Should a significant need for capacity arise in the future due to a natural disaster or other serious need, this option gives the State the possibility to re-activate these facilities at a later date.

Incarcerated people at these locations will be rehoused into appropriate level prisons.

The two prisons were chosen pursuant to criteria set forth by the Legislature in Penal Code Section 2067. CDCR's leadership carefully evaluated the options for prison closures, pursuant to the 2022-23 budget and Penal Code requirements, and took into account several factors including cost to operate, impact of closure on the surrounding communities and the workforce; housing needs for all populations; long-term investments in state-owned and operated correctional facilities; public safety and rehabilitation; and durability of the state's solution to prison overcrowding.

California City Correctional Facility is the last contract facility in CDCR. It is a leased facility with our CoreCivic partners since 2013, and was necessary to help address overcrowding in state prisons. Now that the term of the lease is expiring and there is additional space at nearby facilities, it makes sense to transition our staff and population into our state-owned facilities.

The Department will also engage with impacted employees in the coming months and years, providing employees with State Restrictions of Appointment (SROA)/Surplus status, which affords them hiring preference for their impacted classifications as well as all other classifications for which they may have lateral transfer options throughout the state as well as for all state agencies. These efforts have been successful in prior closures and are subject to labor negotiation. Incarcerated people in the impacted prisons and facilities will be transferred to other institutions or yards based on their housing, custody and rehabilitative needs. All of their rehabilitative, educational and self-help program credits will transfer with them.

Subject: Phased Opening of the Palm Springs Navigation Center

Recommendation: Information

Background: In March 2024, the first phase of the Palm Springs Navigation Center opened in the City of Palm Springs. CVAG's Homelessness Committee received an update at its February meeting from Palm Springs Deputy City Manager Flinn Fagg. Given the overlap between homelessness and general public safety concerns, a written update is being provided to the Public Safety Committee.

The campus was designed as a location where shelter, food and a full suite of support services can be co-located to expand the region's network of services for homeless individuals and reduce secondary impacts that can negatively impact quality of life. The first phase is an early entry facility and the rest of the campus open in Jully 2024. The project was highlighted at the February 1 homelessness symposium that was hosted by Riverside County Supervisor V. Manuel Perez.

The navigation center is located on 3.64 acres along McCarthy Road in the City of Palm Springs. The site has three existing buildings totaling 46,760 square feet. The campus will consist of a shelter facility, 80 modular housing units and full wrap-around services that will include behavioral health care, workforce training, linkage to state and county services, and other resources to get unhoused individuals linked to permanent housing.

The center's focus will be to provide services to help individuals transition into permanent housing. In the future, in addition to providing services directly to homeless individuals, the City and the County have identified the potential to provide services to housed residents such as childcare; assisting individuals with securing health, disability, social security, and other benefits; computer skills, access to internet, employment support and assessments; basic first aid; computer labs; and referrals to other resources. An appropriately sized facility and property could also provide an opportunity to co-locate other services, including the county's mental and/or behavioral health programs, or to have an on-site medical clinic.

CVAG's Homelessness Committee will have its June 2024 meeting at the Navigation Center, which will include a tour of the facility.

Fiscal Analysis: There is no cost to CVAG for this update.

City and county officials have noted that the project's estimated costs have gone up as overall costs of construction have risen. More than \$40 million was secured for the creation and operation of the campus. In August 2022, Riverside County and the City of Palm Springs announced they

were receiving a \$19 million grant from the state's Homekey Program to build and operate the Palm Springs Navigation Center. Riverside County contributed \$18 million and the City of Palm Springs contributed \$8.16 million.

In addition to funding design, renovations and construction, the City and County has secured funding for operational dollars for Martha's Village & Kitchen, which has been selected by the city as the center's operator.
