Subject:Roundtable Discussion on Coachella Valley's Response and Readiness to Active
Shooter Situations at Schools and Other Soft Targets

Background: At the June 2022 meeting of the Public Safety Committee, several members made comments about gun violence, ranging from the tragedy in Uvalde, Texas to recent rallies in the desert. There also were a number of comments about the level of support at local schools, both in terms of security officers as well as mental health services. Following the comments, CVAG staff met with Public Safety Chair Waymond Fermon and Vice Chair Megan Beaman Jacinto about leading a discussion on the topic.

The August 8 special meeting of the Public Safety Committee will be a roundtable forum about the Coachella Valley's readiness and response plans to an active shooter situation, particularly at soft targets such as schools. The roundtable will feature the following speakers:

- Indio Police Chief Mike Washburn;
- Cathedral City Police Chief George Crum;
- Palm Springs Unified School District's Executive Director of Security and Disaster Preparedness Levaughn Smart;
- Desert Sands Unified School District's Assistant Superintendent of Business Services Jordan Aquino and Director of Safety and Security Edward Nacua;
- Coachella Valley Unified School District's Director of Safety and Security Gus Paiz; and
- Riverside University Health System-Behavioral Health's Desert Region Adult Services Administrator Jim Grisham

Local law enforcement and schools have long planned for the unthinkable scenario of an active shooter situation. Additional trainings have been held since the May 24 mass shooting at Robb Elementary School in Uvalde, where 19 children and two teachers died in their classrooms. For example, a recent training by Palm Springs Police Department, which was highlighted in a KESQ in-depth report, included training with semi-automatic rifles and munitions, or non-lethal training ammunition. (https://kesq.com/news/in-depth/2022/07/22/exclusive-embedding-with-palm-springs-police-during-active-shooter-simulation/) Among the other trainings was one held in July when Desert Sands Unified partnered with the Riverside County Sheriff's Department on an active shooter simulation at Palm Desert Charter Middle School. Such trainings are not limited to schools, as the staff at Indio City Hall was recently updated on active shooter scenarios.

There also have been calls for elected officials at the state and federal levels to take legislative steps to curb gun violence at schools. This summer, California Gov. Gavin Newsom signed a series of bills, including Assembly Bill 2571 to ban the marketing of firearms to minors and Assembly Bill 1621 to further recap restrict ghost guns. https://www.gov.ca.gov/2022/07/21/governor-newsom-signs-new-measures-to-protect-californiansfrom-gun-violence/) At the federal level, President Joe Biden in June signed a bipartisan bill that was heralded as the first major gun control measure to pass Congress in nearly three decades. Among the provisions of the bill is expanded background checks for prospective gun buyers between the ages of 18 and 21; expansion of an existing law that prevents people convicted of domestic abuse from owning a gun; and grants meant to encourage states to create so-called red flag laws, allowing law enforcement or other entities to petition a court to remove guns from a person deemed to be a threat to themselves or others.
