# B. Acquisition of nine parcels in the Thousand Palms Conservation Area – Jim Karpiak

Jim Karpiak of the Coachella Valley Mountains Conservancy presented the staff report and provided an overview of the property. Mr. Kirk noted that staff would follow up at the next meeting with specifics on how much property had been acquired by CVCC.
