D. Improvements along Avenue 50 from Oates Lane to State Route 86

Program Manager Julie Mignogna gave the staff report.

Brief member discussion ensued regarding the inclusion of a conditional pay back provision being added to recommendation in the event that the project is not constructed.

Ms. Mignogna presented the staff report.
